- 1. The House met, at three o'clock p.m., pursuant to adjournment.-Mr. Speaker took the Chair, and read Prayers.
- 2. PRIVILEGE.—The honorable Member for Capricornia (Mr. Higgs) read a notice of a motion which he proposed to move with reference to the Opposition.

Mr. Speaker ruled that the notice was not in order.

 - Mr. Fisher moved, That the honorable Member for Maranoa be suspended from the service of the House for the remainder of the sitting.
