- 2. Message from the Senate.—Navigation Bill.—Mr. Speaker announced the receipt of the following Message from the Senate:—

Mr. Speaker,

Message No. 31.

The Senate returns to the House of Representatives the Bill intituled "A Bill for an Act relating to Navigation and Shipping," and acquaints the House that the Senate has agreed to the amendments made by the House of Representatives therein, Nos. 1 to 8, 10 to 20, 22 to 27, 29 to 55, 57 to 71, 73 to 85, 87 to 111, 114 to 122, 124 to 127, 129 to 155, 157, 159 to 170, 172 to 175, and 178; to amendments Nos. 9, 28, 56, 72, 112, 123, 128, 158, 176, and 177 with the amendments indicated in the annexed Schedule; to amendment No. 113 with an amendment, and with a consequential amendment in clause 252, and to amendments Nos. 21, 86, 156, and 171, with consequential amendments in clauses 38, 208, 349, and 421 of the Bill respectively, as shown in the annexed Schedule.

The Senate desires the concurrence of the House of Representatives in the amendments to amendments Nos. 9, 28, 56, 72, 112, 113, 123, 128, 158, 176, and 177, and in the consequential amendments on amendments Nos. 21, 86, 113, 156, and 171, made in clauses 38, 208, 252, 349, and 421 of the Bill.
