THURSDAY, 12TH DECEMBER, 1912.

- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.-Mr. Speaker took the Chair, and read Prayers.
- 2. Papers.—Mr. Thomas presented, by command of His Excellency the Governor-General—

Papua—Annual Report, year ended 30th June, 1912.

Ordered to lie on the Table.

Mr. O'Malley presented, pursuant to Statute-

Public Service Act—Department of Home Affairs—Promotion of W. G. Chapman, to new position of Clerk, 4th Class, Public Works Branch, New South Wales.

3. Supply ["Grievance Day"].—Pursuant to the provisions of Standing Order No. 241, the Order of the Day having been read for going into the Committee of Supply-

Question proposed—That Mr. Speaker do now leave the Chair.

Debate ensued.

Question—put and negatived.

Resolved—That the House will, at a later hour this day, resolve itself into the said Committee.

4. Invalid and Old-age Pensions Bill (1912).—The Order of the Day having been read for the second reading-Mr. Fisher moved, That the Bill be now read a second time.

Debate ensued.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Clause 1 agreed to.

Clause 2-

On the motion of Mr. Brown, after debate, the following amendments were made:-

Line 17, omit "or", and after "grand-daughter" add "or legally adopted son or daughter"

Clause, as amended, agreed to.

Clauses 3, 4, 5 agreed to.

Clause 6-

On the motion of Mr. Charlton the following amendment was made:-

Line 24, after "practitioner" add "or where medical testimony conflicts the Commissioner shall have power to decide the application".

Clause, as amended, agreed to.

Clause 7 debated and agreed to.

Clause 8 agreed to.

Clause 9 debated and agreed to.

Clause 10 debated and agreed to.

Clauses 11, 12, 13 agreed to.

Title agreed to.

Bill to be reported with amendments.

The House resumed; Mr. Poynton reported accordingly.

On the motion of Mr. Fisher, by leave, the House adopted the Report, and the Bill was read a third time.

5. PAPER.—Mr. Fisher presented, by command of His Excellency the Governor-General—

6. JUDICIARY BILL (1912).--The Order of the Day having been read for the second reading-Mr. Hughes moved, That the Bill be now read a second time.

- 8. Sugar Excise Repeal Bill.—Mr. Tudor moved, pursuant to notice, amended, That he have leave to bring in a Bill for an Act to repeal the Excise Duty on Sugar. Question—put and passed.

Mr. Tudor then brought up the Bill accordingly, and moved, That it be now read a first time. Question—put and passed.—Bill read a first time.

Ordered—That the second reading be made an Order of the Day for to-morrow.

9. Sugar Bounty Abolition Bill.-Mr. Tudor moved, pursuant to notice, emended, That he have leave to bring in a Bill for an Act to repeal the Sugar Bounty Act 1905-1912.

Question—put and passed.

Mr. Tudor then brought up the Bill accordingly, and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Ordered—That the second reading be made an Order of the Day for to-morrow.
