The order of the day having been read for the consideration of the amendments made by the Senate—

On the motion of Mr McGauran (Minister for Agriculture, Fisheries and Forestry), amendments 3, 5 and 8 were agreed to, after debate.

On the motion of Mr McGauran, amendments 1, 2, 4, 6, 7 and 9 were disagreed to, after debate.

Mr McGauran presented reasons, which were circulated, and are as follows:

Reasons of the House of Representatives for disagreeing to amendments 1, 2, 4, 6, 7 and 9 of the Senate

These amendments propose changes to the measures contained in the Bill regarding the appointment and authorisation of detention officers under the *Fisheries Management Act 1991* and *Torres Strait Fisheries Act 1984*. Broadly, the purpose of the amendments is to prohibit the appointment of private contractors as detention officers. The amendments limit those people who can be appointed as detention officers to officers and employees of the Commonwealth, States or Territories and/or their authorities including the Australian Fisheries Management Authority.

The Government believes that the amendments would effectively require the establishment of two separate land based facilities with different staff arrangements, as they would prevent private contractors from being appointed as detention officers for people in fisheries detention. The Australian Government Department of Immigration and Multicultural and Indigenous Affairs uses a private contractor to operate its network of immigration detention facilities. Employees of that contractor and relevant subcontractors are appointed as officers under the *Migration Act 1958* to hold detainees and to provide appropriate services in any immigration detention facility. Those officers have been authorised to exercise various powers under the *Migration Act 1958*.

These amendments are unacceptable. They are contrary to the main purpose of the Bill, which is to provide consistent frameworks for fisheries and immigration detention, so that suspected illegal foreign fishers, whether they be in fisheries or immigration detention, can be accommodated together in a joint fisheries/immigration detention facility. This is intended to allow the transition of illegal fishers from fisheries to immigration detention to be free from disruption, in particular, to their physical location. Consistent administrative, security and staffing arrangements are required where people under fisheries and immigration detention are to be held in the same facility to ensure the safety and welfare of all within it, including detainees, staff and visitors. The additional cost of establishing separate regimes for fisheries and immigration detention is prohibitive.

Accordingly, the House of Representatives does not accept these amendments.
