#### 16 PETROL PRICES

Mrs Elliot, pursuant to notice, moved—That this House:

- (1) notes that petrol prices in regional areas have dramatically increased and are averaging well over \$1.20 per litre;
- (2) recognises that these prices are becoming prohibitive for families and small businesses and are adversely impacting on tourism an industry which many regional areas rely on; and
- (3) calls on the Government to direct the Australian Competition and Consumer Commission to formally monitor prices under Part VIIA of the *Trade Practices Act 1974*.

Debate ensued.

#### 17 HEALTH

Mrs May, pursuant to notice, moved—That this House:

- (1) recognises that:
  - (a) good health is the single most important factor necessary for individuals to lead a happy and successful life;
  - (b) what individuals think, eat and the amount of activity they undertake are important determinants of health and wellbeing;
  - (c) Australians have a high incidence of preventable diseases that are influenced by lifestyle and behaviour including cardiovascular diseases, cholesterol, obesity and diabetes;
  - (d) for many Australians, health is simply access to medical goods and services; and
  - (e) once illness has taken hold, because of the mind/body connection, many do not have the mindset to better improve their health until they get a 'scare' which often comes too late; and
- (2) calls on the Australian Government to:
  - (a) educate youngsters in schools about health and ways of preventing illness;
  - (b) educate couples before starting a family on healthy lifestyles for children;
  - (c) refocus the training of our doctors from ill health to good health with an emphasis on preventative care; and
  - (d) implement a National Health Strategy with a strong focus on preventative health.

### Debate ensued.

The time allotted for private Members' business having expired, the debate was interrupted, the resumption of the debate made an order of the day for the next sitting, and Ms Hall was granted leave to continue her speech when the debate is resumed.

#### 20 TAX LAWS AMENDMENT (IMPROVEMENTS TO SELF ASSESSMENT) BILL (NO. 2) 2005

The order of the day having been read for the resumption of the debate on the question—That the bill be now read a second time—And on the amendment moved thereto by Mr Fitzgibbon, viz.—That all words

after "That" be omitted with a view to substituting the following words: "whilst not declining to give the bill a second reading, the House condemns the Government for:

- (1) maintaining and allowing the self assessment system to so seriously deteriorate over a long period of time so these radical reforms are needed;
- (2) failing to provide sufficient certainty on how oral advice will be recorded and made available; and
- (3) failure to clarify in this bill how the personal tax affairs of a taxpayer will be linked to the tax affairs of a company with which the taxpayer is associated"—

Debate resumed.

Amendment negatived.

Question—That the bill be now read a second time—put and passed—bill read a second time.

Leave granted for third reading to be moved immediately.

On the motion of Mr Brough (Minister for Revenue and Assistant Treasurer), the bill was read a third time.

# 21 HIGHER EDUCATION LEGISLATION AMENDMENT (2005 BUDGET MEASURES) BILL 2005—SENATE'S AMENDMENTS

The order of the day having been read for the consideration of the amendments made by the Senate—

Constitutional significance of Senate amendments—Statement by Deputy Speaker

The Deputy Speaker made a statement concerning two of the Senate amendments with respect to this bill, and the matters of constitutional principle they raised. Proposed Senate amendments (1) and (2), if enacted, would have the effect of moving expenditure between financial years. The view has been taken that legally this would amount to a change in the destination of the appropriation.

There is doubt that the Senate may proceed in these circumstances by way of amendment because of section 53 of the Constitution. Among other things, this section prohibits the Senate from amending a bill so as to increase 'any proposed charge or burden on the people'.

The view has been taken that where expenditure is to be transferred in such circumstances, section 56 of the Constitution requires that the proposed appropriation must be recommended by a message from the Governor-General. Such a message has been obtained in this case.

The House will need to consider the way in which it should proceed to deal with the matters raised in Senate amendments (1) and (2). If it wishes to entertain the proposals reflected in the amendments, it may choose to proceed by alternative means.

The matter for consideration is not so much one of the privileges and rights between the two Houses but observance of the requirements of the Constitution concerning the appropriation of revenue.

Dr Nelson (Minister for Education, Science and Training) moved—That the House endorse the statement of the Deputy Speaker in relation to the constitutional questions raised by Message No. 216 transmitted by the Senate in relation to the Higher Education Legislation Amendment (2005 Budget Measures) Bill 2005.

Question—put and passed.

On the motion of Dr Nelson, amendment No. 3 was agreed to, after debate.

On the motion of Dr Nelson, amendments Nos 1 and 2 were disagreed to.

Message from the Governor-General

Message No. 125, 6 September 2005, from His Excellency the Governor-General, was announced recommending an appropriation for the purposes of amendments to the bill.

Dr Nelson moved—That Government amendments Nos 2 and 3 be made in place of the Senate's amendments Nos 1 and 2 which were disagreed to.
