- (4) calls on the Vietnamese Government to observe its international obligations on human rights, including the provision of free and fair elections; and
- (5) notes the Australian Government's active support for, and promotion of, democratic freedoms and human rights in Vietnam, including through the annual human rights dialogue and other cooperation programs, and encourages the Government to continue these efforts.
