9 TRADE PRACTICES LEGISLATION AMENDMENT BILL 2008—SENATE'S AMENDMENTS

The order of the day having been read for the consideration of the amendments made by the Senate— On the motion of Mr Bowen (Minister for Competition Policy and Consumer Affairs), amendments Nos 1, 3, 4, 6 and 7 were agreed to.

On the motion of Mr Bowen, amendments Nos 2 and 5 were disagreed to, after debate.

Mr Bowen presented reasons for the House disagreeing to Senate amendments Nos 2 and 5, which were circulated, and are as follows:

Reasons of the House of Representatives for disagreeing to the amendments of the Senate

The House disagrees with Senate amendments (2) and (5).

During consideration in the House, the Opposition moved an amendment to the second reading motion, calling on the Government to abandon its plans to allow the Federal Magistrates Court (FMC) to hear section 46 matters. However, in the Senate the Opposition failed to oppose the Government amendment that actually bestows jurisdiction on the FMC (Schedule 1, item 7).

The House rejects the Senate amendments as they give rise to uncertainty as to the operation of section 46. Particular provisions of section 46 are currently expressed to apply to the Federal Court, such as subsections 46(3), (3A) and (3C). As a result of the Senate amendments, these provisions will continue to refer to the Federal Court despite the FMC having jurisdiction to hear such matter. This could give rise to confusion, and potentially limits the application of important parts of section 46 that facilitate its operation.

3 FAMILY, COMMUNITY, HOUSING AND YOUTH—STANDING COMMITTEE—MOTION TO TAKE NOTE OF DOCUMENT

The order of the day having been read for the resumption of the debate on the motion of Ms A. L. Ellis—That the House take note of the document (*presented on 13 October 2008*), *viz.*—

Family, Community, Housing and Youth—Standing Committee—The value of volunteering: A discussion paper on volunteering in the community and welfare sector—Report, September 2008—Debate resumed.

Debate adjourned (Mr Danby), and the resumption of the debate made an order of the day for the next sitting.

4 NATIONAL RENTAL AFFORDABILITY SCHEME BILL 2008

The order of the day having been read for the resumption of the debate on the question—That the bill be now read a second time—And on the amendment moved thereto by Mr Morrison, viz.—That all words after "That" be omitted with a view to substituting the following words: "while not declining to give this bill a second reading, the House calls on the Government to make such amendments to the National Rental Affordability Scheme as would:

- (1) provide for incentives to be given on a sliding scale to take account of the different development and land costs in different locations;
- (2) provide for successful applicants to transfer their tax offsets on a once only basis to project financiers in return for a lower cost of funds, including providing such tax offsets to not for profit entities for this purpose;
- (3) require that State and Territory governments match the incentives provided by the Commonwealth under the Scheme;

- (4) extend project eligibility criteria to include conversions to affordable housing from existing residential stock, particularly where such projects involve substantial redevelopment to provide for specific needs groups such as aged or disabled accommodation;
- (5) extend the upper level income limits for tenant income eligibility criteria by 30 per cent in each band to ensure greater access for key workers and those seeking to save to buy their first homes;
- (6) provide 'as of right' eligibility for the Federal Government's solar panel rebate and solar hot water rebate schemes; and
- (7) extend the establishment phase criteria that approximately 20 per cent of incentives be available for projects of not less than 20 dwellings, to the entire Scheme"—

Debate resumed

Mr Sidebottom was granted leave to continue his speech when the debate is resumed.

Debate adjourned, and the resumption of the debate made an order of the day for the next sitting.

Mr Melham moved—That the Main Committee do now adjourn.

Debate ensued.

Question—put and passed.
