Mr Turnbull moved—That so much of the standing and sessional orders be suspended as would prevent the Member for Wentworth moving immediately—That this House censures the Prime Minister for losing control of Australia's borders with badly thought through policy changes that have dramatically increased the number of unauthorised boat arrivals and handed control of our immigration policy to the people smugglers, and in particular for:

- (1) failing to be upfront and honest with this House, and the Australian people, about the nature of the special deal done for the asylum seekers on board the *Oceanic Viking*;
- (2) the Prime Minister's inept handling of the diplomatic relationship with Indonesia; and
- (3) trying to abrogate his responsibility to take charge of this latest border protection crisis by hiding behind a wall of spin, his own staff and the bureaucracy when as he said himself, he is the Prime Minister and the buck stops with him.

Debate ensued.

Question—That the motion for the suspension of standing and sessional orders be agreed to—put.
