1 The House met, at 9 a.m., pursuant to adjournment. The Speaker (Mr Jenkins) took the Chair, and read Prayers.

## 2 PRIVILEGE—STATEMENT BY SPEAKER

The Speaker made a statement concerning the matter of privilege raised by Mr Albanese (Leader of the House) on Monday, in relation to reports that the Member for Ryan had complained to police authorities that he had been subject to undue pressure and intimidation to resign from Parliament.

The Speaker said that the Leader of the House had suggested that the alleged actions could constitute a contempt as an improper interference with the free performance by the Member of his duties as a member. The Member for Ryan had supported consideration of the issue as a matter of privilege and had provided some detail of the actions that had been of concern to him.

The Speaker stated that he had considered the comments by the Leader of the House and the Member for Ryan and had had regard to relevant precedents. In *House of Representatives Practice* it is stated that an attempt to influence a Member in his or her conduct as a member by threats is a contempt, as is any conduct having a tendency to impair a member's independence in the future. To be an offence against the House, conduct has to be found to amount to, or be intended or likely to amount to, improper interference.

The Speaker said that complaints of breach of privilege relating to matters arising within political parties had been raised in the House before, although no cases had been referred to the Committee of Privileges. In responding to the complaints, former Speakers had noted, using precedents from the United Kingdom, that arrangements within political parties are unlikely to give rise to matters of privilege or contempt. It had also been noted that the raising of the complaint by a third party may not be a good foundation for action being taken in the area. The view had been expressed, however, that if any Member sought the protection of the House in such matters, the House ought to seek the advice of the Committee of Privileges as to the proper course.

The Speaker said that, although no reference on such matters had been made by the House, the Senate Committee of Privileges had reported on a case involving party processes. In this case, involving Senator Tambling, who had been disendorsed by his party, the committee found that a penalty had been imposed on him on account of his vote on a certain matter, and that, although the actions of the party were "reckless and ill judged", on balance, and in light of certain developments, a contempt should not be found.

The Speaker also referred briefly to a case in New Zealand in 1993, in which the High Court had considered a matter involving the disendorsement of a member of Parliament from the political party of which he had been a long-standing member. The court noted that there must be no question of discipline or coercion which could in some way influence the manner in which a member of Parliament went about his or her business. The judgement went on to say, however, this had nothing to do with choosing candidates to promote for election, and so did not involve matters of privilege.

The Speaker stated that, while the matters he had referred to were not directly comparable, they illustrated that questions relating to the operation of political parties could present particular issues in relation to privilege. There seemed to be a recognized role for political parties in dealing with matters of internal discipline and the endorsement of candidates, and that such actions might at times be quite robust without being improper. However, it is the case that action taken within a political party could

potentially amount to an improper interference with the free performance by a member of his or her duties.

The Speaker stated that the question of whether such action would be found to amount to a contempt would be dependent on the particular circumstances.

The Speaker said that the following points were relevant in his consideration of the matter:

- (1) intimidating a member with a view to influencing the behaviour of a member in relation to his or her duties was a very serious matter;
- (2) the Member concerned in the case had supported the initial complaint and provided some detail;
- (3) the matters complained of were focussed on activities within a political party and were related to questions of the endorsement of a member as a candidate for a political party; and
- (4) the Member had confirmed that he had referred his concerns to the police.

The allegations were serious and went to the ability of a member to be able to perform his duties freely and without proper interference, and the fact that they had occurred within the context of a political party did not make them immune from considerations of possible improper interference.

The Speaker stated that these were areas in which the House did not have precedents of its own to guide it and that the matter was distinguished from earlier cases in the House because the Member concerned had spoken in support of the complaint and had provided details of his concerns that he had been subject to intimidation. Whilst the matter had been referred to the police, the Speaker's role was to consider the matter in terms of parliamentary law and practice. Having regard to the material before him, the Speaker concluded that he was willing to allow precedence to a motion. The Speaker said that the complaint might allow the House to receive advice in an area in which it had not had the benefit of informed consideration.

# 3 MATTER RAISED IN RELATION TO THE MEMBER FOR RYAN—REFERENCE TO COMMITTEE OF PRIVILEGES AND MEMBERS' INTERESTS

Mr Albanese (Leader of the House) moved—That the following matter be referred to the Committee of Privileges and Members' Interests: having regard to the matters raised in the House on 31 May by the Leader of the House and referred to in the House on 2 June by the Member for Ryan, whether the Member for Ryan has been subject to improper interference, or attempted improper interference, with the free performance of his duties as a Member, and, if so, whether a contempt has been committed.

Question-put and passed.

## 4 EXCISE TARIFF AMENDMENT (AVIATION FUEL) BILL 2010

Mr Albanese (Minister for Infrastructure, Transport, Regional Development and Local Government) presented a Bill for an Act to amend the *Excise Tariff Act 1921*.
