### THURSDAY, 23RD OCTOBER, 1913.

- The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. Decimal System.—Mr. Dankel moved, pursuant to notice, That, in the opinion of this House, the Government should take into consideration the advisableness of establishing the decimal system in respect to coinage and weights and measures.

  Debate ensued.

Mr. Groom moved, That the debate be now adjourned.

Question-That the debate be now adjourned-put and passed.

- Ordered -- That the resumption of the debate be made an Order of the Day for Thursday, 20th November next.
- 3. Pensioners, Old-age and Invalid—Increase of Payments to.—Mr. Chapman moved, pursuant to Order, That, owing to the increased cost of living, an increase should be made in the payments to old-age and invalid pensioners.

Debate ensued.

Sir John Forrest moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

- Ordered—That the resumption of the debate be made an Order of the Day for Thursday, 20th November next.
- 4. Elections—Royal Commission.—Mr. Sinclair moved, pursuant to Order, That a Royal Commission consisting of five Members of this House should be appointed to inquire into and report upon—
  - (a) the conduct of the Federal Elections, 1913;
  - (b) a better method of purifying the electoral rolls;
  - (c) the prevention of plural voting or personation at elections;
  - (d) a more perfect system of conducting elections.

Debate ensued.

Question—put and passed.

"That, in the opinion of the Senate, section 51 of the Constitution Act should be amended to give the Parliament of the Commonwealth power to grant pensions to widows with young children dependent on them; and that the necessary referendum of the electors of the Commonwealth be taken at the next general election."
