Mr. Glynn, on behalf of the Committee, brought up such Reasons which were read and are as follow:—

Reasons of the House of Representatives for Disagreeing to the Amendments of the Senate-

As to No. 1. Because it is inexpedient to provide for the election of the Executive Council, a body of limited administrative and no strictly legislative powers, by the adult population of Norfolk Island, and any change in the method of appointment of the members of the Council should be made as part of the provisions of a measure for better government of the Island passed under the powers conferred by this Act.

As to Nos. 2 and 3. Because it is inexpedient by this Bill to alter the present land system which has been found suited to Norfolk Island, and under which lands may be granted for an estate of freehold or may be leased, and no evils that legislation cannot remedy can arise.

Mr. Glynn moved, That the Committee's Reasons be adopted. Question—put and passed.

13. Message from the Senate.—Loan Bill (1913).—Mr. Speaker announced the receipt of the following Message from the Senate:-

Mr. Speaker,

The Senate returns to the House of Representatives the Bill for "An Act to authorize the raising and expending of the sum of Three million and eighty thousand pounds for certain purposes," and acquaints the House of Representatives that the Senate does not insist upon its amendment No. 3, disagreed to by the House of Representatives.

The Senate insists upon its amendment No. 4, disagreed to by the House of Representatives, as shown in the annexed Schedule, has consequentially altered amendments Nos. 1 and 2, as shown in the annexed Schedule, and requests the reconsideration of the Bill in respect to amendments Nos. 1, 2, and 4.
