# HOUSE OF REPRESENTATIVES.

### WEDNESDAY, 21st OCTOBER, 1914.

- 1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. PRESENTATION OF ADDRESS IN REPLY.—Mr. Fisher informed the House that the Address in Reply would be presented to His Excellency the Governor-General at a quarter past three o'clock to-morrow afternoon in the Parliamentary Library.
- 3. ORDER OF BUSINESS.—Mr. Fisher moved, by leave, That on Wednesday and Friday in each week, unless otherwise ordered, Government Business shall take precedence of all other business; and that on each Thursday until half-past six o'clock, unless otherwise ordered, General Business shall take precedence of Government Business. Question—put and passed.
- 4. ORDER OF GENERAL BUSINESS.—Mr. Fisher moved, by leave, That on Thursday in each week, unless otherwise ordered, General Business shall be called on in the following order, viz. :--

On one Thursday— Notices of Motion. Orders of the Day.

On the alternate Thursday– Orders of the Day.

Question—put and passed.

- 5. STANDING ORDERS COMMITTEE.—Mr. Fisher moved, by leave, That Mr. Speaker, the Prime Minister, the Chairman of Committees, Mr. Joseph Cook, Mr. Fowler, Mr. Poynton, and Mr. Sampson be Members of the Standing Orders Committee; three to form a quorum. Question—put and passed.
- 6. LIBRARY COMMITTEE.—Mr. Fisher moved, by leave, That Mr. Speaker, Mr. Anstey, Mr. Glynn, Mr. Higgs, Mr. W. Elliot Johnson, Mr. W. Maloney, Mr. Bruce Smith and Mr. Wise be Members of the Library Committee; three to form a quorum. Question—put and passed.
- HOUSE COMMITTEE.—Mr. Fisher moved, by leave, That Mr. Speaker, Mr. Burchell, Mr. Fleming, Mr. R. W. Foster, Mr. Mathews, Mr. O'Malley, Mr. Rodgers, and Mr. Yates be Members of the House Committee; three to form a quorum. Question—put and passed.
- PRINTING COMMITTEE.—Mr. Fisher moved, by leave, That Mr. Bamford, Mr. Charlton, Mr. Fenton, McWilliams, Mr. Palmer, Mr. Stumm, and Mr. Watkins be Members of the Printing Committee; three to form a quorum; with power to confer with a similar Committee of the Senate. Question—put and passed.

#### (In the Committee.)

Resolved, on the motion of Mr. Fisher-That it is expedient that an appropriation of revenue be made for the purposes of a Bill for an Act to grant and apply out of the Consolidated Revenue Fund the sum of One hundred thousand pounds as a grant in aid to the Government of Belgium.

Resolution to be reported.

The House resumed; Mr. Chanter reported accordingly.

Ordered-That the Report be considered at once.

And, on the motion of Mr. Fisher, the said Resolution was adopted by the House. Ordered—That Mr. Fisher and Mr. Hughes do prepare and bring in a Bill to carry out the foregoing Resolution.

Mr. Fisher then brought up the Bill accordingly, and moved, That it be now read a first time. Question-put and passed.-Bill read a first time.

Mr. Fisher moved, by leave, That the Standing Orders be suspended, to enable the Bill to be passed through its remaining stages without delay.

Clause 2 debated and, on the motion of Mr. Hughes, amended by omitting "and" in line 22; by inserting after paragraph (a), the following new paragraph (b)

"(b) any act or transaction which is prohibited by or under any proclamation made by the Governor-General and published in the Gazette, or ";

and by omitting "(b)" in line 23 and inserting "(c)".

Clause, as amended, agreed to.

Clause 3 agreed to.

Clause 4 amended, on the motion of Mr. Hughes, after debate, by omitting from line 15 (page 3) the word "Fifty" and inserting the words "Five hundred", and by omitting the words "six months" and inserting the words "one year".

Clause, as amended, agreed to.

Clause 5 amended, on the motion of Mr. Hughes, by adding the words "or proceedings under this Act ".

Clause, as amended, agreed to.

Clauses 6 and 7 agreed to.

On the motion of Mr. Hughes, the following New Clause was added to the Bill :-

"6A. For the purposes of this Act evidence of any proclamation issued by Evidence of the King or by the Governor-General may be given in all Courts by the production proclamation.
