- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.

PRESENTATION OF ADDRESS IN REPLY TO HIS EXCELLENCY THE GOVERNOR-GENERAL.—Mr. Speaker reported that, accompanied by honorable Members, he had, on the 29th ultimo, waited upon His Excellency the Governor-General, in the Parliamentary Library, and had presented to him the Address in Reply to His Excellency's Speech on the Opening of Parliament, agreed to by the House on the 15th ultimo, and that His Excellency had made the following reply:—
