## FRIDAY, 18TH DECEMBER, 1914.

1. The House met, at twelve o'clock noon, pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.

2. THE RIGHT HONORABLE JOSEPH COOK-APOLOGY TO MR. SPEAKER.-Mr. Speaker read to the House the following letter :--

House of Representatives, Melbourne, 18th December, 1914.

DEAR MR. SPEAKER,

On reading my Hansard proof this morning, I find I am reported as saying :---

"I decline to take any further part in the proceedings of this House, on account of the tyrannical way in which Mr. Speaker conducts them."

While smarting under a very keen sense of injustice, I none the less realize that the expression, used in the heat of debate, is one which should not have been uttered, and I unreservedly withdraw it, and desire to make you an ample apology.

Mr. Speaker made a statement to the House concerning the matter, and stated he had accepted the apology of the honorable Member.

3. PRIVILEGE—RIGHT OF MEMBER WHO APPEALS AGAINST MR. SPEAKER'S RULING.—Sir William Irvine moved, That the right to appeal to the House from any ruling of the Speaker by objection in writing and motion under Standing Order 287, is the privilege of every Member of the House, and that it is essential to the maintenance of that privilege that the Speaker should submit the motion in the form in which the Member puts it, and should not refuse to put any such motion on the ground that, in his opinion, it does not correctly state the facts or the nature of the ruling, and that the House on such motion should determine all such questions.

4. ESTATE DUTY ASSESSMENT BILL .- SENATE'S AMENDMENTS.-The Order of the Day having been read for the consideration in Committee of the whole House of the Amendments made by the Senate in this Bill-Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

The Committee proceeded to consider the Amendments, which are as follow :----

SCHEDULE OF THE AMENDMENTS MADE BY THE SENATE.

No. 1.-Page 4, clause 8, after sub-clause (7.) add the following new sub-clause :---

"(8.) In this Act, 'public educational purposes' includes the establishment or endowment of an educational institution for the benefit of the public or a section of the public."

No. 2.—Page 8, clause 28, line 17, leave out "sub-section (1.) of".

No. 3.—Page 8, clause 29, line 19, after "payable" insert "by the administrator". No, 4.—Page 9, clause 35, line 14, after "apportioned" insert "by the administrator".

No. 5.-Page 10, clause 41, line 28, leave out "or trustee".

On the motion of Mr. Fisher, after debate, the Committee agreed to the Amendments. Resolutions to be reported.

The House resumed; Mr. W. Maloney reported accordingly. On the motion of Mr. Fisher, the House adopted the Report.

5. TREASURY BILLS BILL. - SENATE'S AMENDMENTS. - The Order of the Day having been read for the consideration in Committee of the whole House of the Amendments made by the Senate in this Bill-Mr. Deputy-Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

#### (In the Committee.)

The Committee proceeded to consider the Amendments, which are as follow :---

Schedule of the Amendments made by the Senate.

- No. 1.--Page 3, clause 13, line 18, after "it" insert "or makes or has in his possession any instrument or thing for the purpose of making any imitation of any descriptive mark or signature on any Treasury Bill or coupon for the payment of money in respect of a Treasury Bill,".
- No. 2.—Page 3, clause 13, lines 26-31, leave out "or (c) makes or has in his possession any instrument or thing for the purpose of making any imitation of any descriptive mark or signature on any Treasury Bill or coupon for the payment of money in respect of a Treasury Bill,".

On the motion of Mr. Fisher, the Committee agreed to the Amendments. Resolution to be reported.

The House resumed ; Mr. W. Maloney reported accordingly. On the motion of Mr. Fisher, the House adopted the Report.

- 6. SPECIAL ADJOURNMENT .---- Mr. Fisher moved, That the House. at its rising, adjourn until Wednesday, 14th April, 1915, unless Mr. Speaker shall, prior to that date, by telegram addressed to each Member of the House, fix an earlier day of meeting. Question—put and passed.
- 7. LEAVE OF ABSENCE TO ALL MEMBERS .- Mr. Fisher moved, by leave, That leave of absence be granted to every Member of the House of Representatives from the determination of the last sitting of the House in the year 1914 to the date of its first sitting in the year 1915. Debate ensued.

- 8. LEAVE OF ABSENCE TO MEMBER (COLONEL RYRIE).-Mr. Fisher moved, by leave, That leave of absence for the remainder of the Session be given to the honorable Member for North Sydney (Colonel Ryrie), absent on public service. Question—put and passed.
- 9. PAPER.—The following Paper was presented, by command of His Excellency the Governor-General— Attorney-General's Department-
  - Conciliation and Arbitration .- Report of Proceedings taken under the Conciliation and Arbitration Act 1904-1911, and Arbitration (Public Service) Act 1911, for the year 1913, and up to 1st May, 1914.

Ordered to lie on the Table, and to be printed.

Amendment made by the House of Representatives, viz. :--

Page 3, clause 14, line 42, after the word "paragraphs :--- " insert the following paragraph :---

"and (da) Persons who are employed in a civil capacity for any purpose in connexion with the Defence Force (whether subject to the Commonwealth Public Service Act 1902-1913 or not), or in any factory established in pursuance of this Act;".

Amendment of House disagreed to but following consequential amendment made in the Bill :---

Page 4, clause 14, at end of clause add-

(5) The Minister may by order under his hand exempt persons who are employed in a civil capacity for any purpose in connexion with the Defence Force (whether subject to the Commonwealth Public Service Act 1902-1913 or not), or in any factory established in pursuance of this Act."

On the motion of Mr. Mahon, the Committee agreed not to insist on the amendment made by the House, and to agree to the consequential amendment made by the Senate.
