- ⁻⁻2. MESSAGE FROM THE GOVERNOR-GENERAL.—ASSENT TO PATENTS, TRADE MARKS AND DESIGNS BILL (1915).—The following Message from His Excellency the Governor-General was presented, and the same was read by Mr. Speaker :—

A Bill intituled "An Act to amend the 'Patents, Trade Marks and Designs Acts 1914,'" as finally passed by the Senate and the House of Representatives of the Commonwealth, having been presented to the Governor-General for the Royal Assent, His Excellency has, in the name and on behalf of His Majesty, assented to the said Act.

· 3. THE WAR.—AUSTRALIAN EXPEDITIONARY FORCES IN ACTION—GENERAL BRIDGES.—Mr. Fisher, by leave, made the following statement to the House :—

"I regret to inform the House that since it last met we have received word that General Bridges, our Officer Commanding the Commonwealth Forces at the Dardanelles, was seriously wounded on the 15th instant. Subsequently he displayed great courage and cheerfulness, but those near him apparently realise the very serious nature of his injuries.

I am sure that I only express the wishes and hopes of this Parliament and the people of Australia that his wounds may not prove fatal.

We are proud of our Forces and the heroic deeds performed by them in the enormously difficult task with which they were confronted at the Dardanelles, and whilst we deeply regret that the casualties sustained in all ranks are high we are consoled by the knowledge that our gallant soldiers have earned the admiration of all.

They have made history that will inspire Australians in all ages to come, and General Bridges' name will always be associated with their splendid performances."

Mr. Joseph Cook also addressed the House, in sympathetic and complimentary terms.

Page 2, line 15, omit "in relation" and insert "such rights and obligations as relate".

Page 2, line 17, at end of sub-clause (5) insert "or such as arise out of or in consideration for such delivery or performance".

Clause, as amended, agreed to.

Clause 4 debated and agreed to.

Title agreed to.

Bill to be reported with amendments.

The House resumed; Mr. Chanter reported accordingly.

Mr. Hughes moved, pursuant to contingent notice, That the Standing Orders be suspended to ... penable the Report to be adopted.

Question—put and passed. On the motion of Mr. Hughes, the House adopted the Report, and the third reading was made an Order of the Day for to-morrow.

- 9. THE WAR-SUBMARINE AE2.-Mr. Jensen, having obtained leave to make a statement, informed the House, with great regret, that it appeared that the reported loss of the Australian submarine AE2 was authentic.
