- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. PAPER.—The following Paper was presented, by command of His Excellency the Governor-General—. Department of Trade and Customs-

Fisheries—Fishing Experiments carried on by F.I.S. Endeavour—Biological results, Vol. III., Part 3.

Ordered to lie on the Table.

3. FEDERAL CAPITAL—REDUCTION OF EXPENDITURE ON.—Mr. Palmer moved, pursuant to notice, That, in the opinion of this House, expenditure upon the Federal Capital should be reduced to a minimum during the financial stress occasioned by the drought and the war. Debate ensued.

Question-put and negatived.

- 4. Postponement of Notice of Motion.—Ordered—That Notice of Motion, General Business, No. 2 be postponed until Thursday, 3rd June next.
- 5. MAIL CONTRACTORS AND PRICE OF FODDER .-- Mr. McGrath moved, pursuant to notice, That, in the opinion of this House, allowances should be made to mail contractors who are suffering severe financial losses owing to the increase in the price of fodder that has taken place since the acceptance of contracts.

Debate ensued.

Question-put and passed.

6. Message from the Senate.—Jervis Bay Territory Acceptance Bill.—Mr. Speaker announced the receipt of the following Message from the Senate:-

The War—Death of General Bridges, C.M.G.—Mr. Fisher moved, by leave, That this House expresses its deep sense of the loss sustaized by the Commonwealth in the death on the battle-field of Major-General Bridges, C.M.G., Officer Commanding the First Division of the Australian Imperial Force, and places on record its deep appreciation of his great services in the development of our defence system, and its admiration of his organization and leadership of the Australian Forces now in action in the Dardanelles. It also tenders its respectful sympathy to the family of this distinguished soldier.

Mr. Joseph Cook, and Mr. Kelly having spoken in support of the motion, and all Members present having risen in silence—

Question—put and passed.

11. ADJOURNMENT.—Mr. Fisher moved, That the House do now adjourn. Question—put and passed.
