- 5. TERRITORY ANNEXED IN THE PACIFIC-PROHIBITION OF INTOXICANTS.-Mr. W. Elliot Johnson moved, pursuant to notice, That, in the interests of sound health, good order, and effective administration, this House is of opinion that it is desirable to prohibit the supply or sale of intoxicants, other than for medicinal purposes, in any territory seized from the enemy in the Pacific and placed under the administration of the Commonwealth, and that the carrying of this resolution be an instruction to the Government to give effect to same.

  - (2) That the carrying of this resolution be an instruction to the Government to take all necessary steps to expedite the construction of the necessary accommodation.
