### FRIDAY, 25TH JUNE, 1915.

- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. ADJOURNMENT-MOTION FOR PURPOSE OF DISCUSSION. Mr. Joseph Cook rose in his place, and said that he proposed to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely, "The delay in instituting a second shift at the Small-Arms Factory."

Mr. Speaker thereupon called upon those Members who approved of the proposed discussion to rise in their places, and more than the necessary number of Members having risen accordingly— Mr. Joseph Cook moved, That the House do now adjourn.

Debate ensued.

- It being two hours after the time fixed for the meeting of the House, in accordance with Standing Order No. 119 the Orders of the Day were called on.
- 3. SUPPLY [ESTIMATES 1914-15].—The House, according to Order, resolved itself into the Committee of Supply.
