- 1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- PETITION. --Mr. Greene presented a Petition from C. J. McRae and A. S. McKenzie, styling themselves President and Secretary respectively of the Dairy Factories Association of New South Wales, Northern Rivers Branch, in reference to the Necessary Commodities Commission Act of New South Wales and the action of the Attorney-General of that State in prohibiting the export of butter from New South Wales, and praying that such steps may be taken as will assure the Petitioners in the free exercise of their rights under the Constitution Act, and that Inter-State free trade may be preserved in its entirety. Petition ordered to be received and read.
- 3. MESSAGE FROM THE SENATE. -- MINISTERS OF STATE BILL.-- Mr. Speaker announced the receipt of the following Message from the Senate :---
