- 1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.

- 3. THE WAR—EXPORT OF COAL FROM AUSTRALIA.—Mr. Fisher, by leave, read to the House a statement explaining the steps taken by the Government to facilitate the export of coal from Australia.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.
