1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.-Mr. Speaker took the Chair, and read Prayers.

3. CONCILIATION AND ARBITRATION BILL (1915) .- Mr. Hughes, pursuant to leave given on the 19th instant, brought up a Bill intituled "A Bill for an Act to amend the 'Commonwealth Conciliation and Arbitration Act 1904-1914,'" and moved, That it be now read a first time. Question—put and passed.—Bill read a first time.

Ordered—That the second reading be made an Order of the Day for the next day of sitting.

- 4. ADJOURNMENT-MOTION FOR PURPOSE OF DISCUSSION .- Mr. Kelly rose in his place, and said that he proposed to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely, "The permission given to Mr. Julius Blau to visit the United States of America, and the subsequent importation of quantities of 4711 eau de Cologne." Mr. Speaker thereupon called upon those Members who approved of the proposed discussion to rise
  - in their places, and more than the necessary number of Members having risen accordingly-

Mr. Kelly moved, That the House do now adjourn.

Mr. Hughes, addressing the House, and not having, in compliance with Standing Order No. 39, concluded his speech within fifteen minutes, the honorable Member was, by leave of the House, allowed to continue his speech.

Debate continued.

It being two hours after the time fixed for the meeting of the House, in accordance with Standing Order No. 119, the Business of the Day was called on.

5. SUPPLY [FINANCIAL STATEMENT AND SUPPLY BILLS]. - The House, according to Order, resolved itself into the Committee of Supply.

Debate resumed on the following motion of Mr. Fisher:—That a sum not exceeding Sixteen million one hundred and ninety-five thousand four hundred and sixty-nine pounds be granted to His Majesty for or towards defraying the services of the year ending 30th June, 1916.

Progress to be reported, and leave asked to sit again.

The House resumed ; Mr. Chanter reported accordingly. Resolved—That the House will, on Wednesday next, again resolve itself into the said Committee.
