CUSTOMS HOUSE, SYDNEY: ALTERATIONS &C.—FURTHER REMISSION TO PUBLIC WORKS COMMITTEE Mr. O'Malley moved, pursuant to notice, That the Parliamentary Standing Committee on Public Works having reported to the House the result of their inquiries into the proposed alterations and additions to the Customs House, Sydney, and the Minister having obtained estimates of cost, £51,481 7s. 11d., tabled herewith, more closely calculated than those upon which the Committee reported, involving virtually double the Committee's estimate of cost, £29,000, the House resolves that their Report be remitted to the Committee for further consideration, and report as to the expediency of the work.
 - Mr. Joseph Cook, addressing the House, and not having concluded his speech, the House ordered that he have leave to continue his speech when the debate is resumed.
 - Ordered-That the debate be now adjourned, and that the resumption of the debate be made an Order of the Day for to-morrow.
