That, notwithstanding the several sums already voted in this present Session of Parliament for such services, the amount granted to His Majesty to the service of the year 1915-16 for the purposes of Additions, New Works, Buildings, &c., shall be a sum not exceeding £3,278,499.

Leave to be asked to sit again.

Resolved, on the motion of Mr. Higgs-That, towards making good the Supply granted to His Majesty for the services of the year 1915-16, a sum not exceeding Four million twenty-four thousand nine hundred and eighty-two pounds be granted out of the Consolidated Revenue Fund.

Additions, New Works, Buildings, etc., 1915-16.

Resolved, on the motion of Mr. Higgs-That, notwithstanding the several sums already voted in this present Session of Parliament for such purpose, the amount granted towards making good the Supply granted to His Majesty for Additions, New Works, Buildings, &c., for the year 1915-16 out of the Consolidated Revenue Fund shall be a sum not exceeding Three million two hundred and seventy-eight thousand four hundred and ninety-nine pounds.

Resolutions to be reported, and leave asked to sit again.
