# MONDAY, 22nd MAY, 1916.

- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. Paper.—The following Paper was presented, by command of His Excellency the Governor-General— Department of External Affairs-

Australian Institute of Tropical Medicine, Townsville, Queensland.—Half-yearly Report from 1st July to 31st December, 1915.

Ordered to lie on the Table, and to be printed.

3. WAR LOAN BILL (UNITED KINGDOM) (No. 1) (1916).—Mr. Higgs moved, by leave, That he have leave to bring in a Bill for an Act to amend the War Loan Act 1914, and the War Loan Act (No. 2) 1915. Question—put and passed.

Mr. Higgs then brought up the Bill accordingly, and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Ordered, by leave—That the second reading be made an Order of the Day for a later hour this day.

- 4. REPRESENTATION BILL.-Mr. Tudor moved, pursuant to notice, That he have leave to bring in a Bill for an Act relating to the appointment of an Enumeration Day for the purposes of the Representation Act 1905. Question-put and passed.
- 5. WAR PENSIONS BILL (1916).—The Order of the Day having been read for the consideration in Committee of the whole House of His Excellency the Governor-General's Message No. 131—Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

# (In the Committee.)

Resolved, on the motion of Mr. Higgs, after debate-That it is expedient that an appropriation of revenue be made for the purposes of a Bill for an Act to amend the War Pensions Act 1914-1915.

Resolution to be reported.

The House resumed; Mr. Chanter reported accordingly.

Mr. Higgs moved, pursuant to contingent notice, That the Standing Orders be suspended, to enable the remaining stages to be passed without delay.

Question—put and passed.

The Resolution reported from the Committee was read and, on the motion of Mr. Higgs, was adopted by the House.

Ordered-That Mr. Higgs and Mr. Tudor do prepare and bring in a Bill to carry out the foregoing Resolution.

Mr. Higgs then brought up the Bill accordingly, and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Mr. Higgs moved, That the Bill be now read a second time.

Debate ensued.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair; and the House resolved itself into a Committee of the Whole. F.12571.

Clause, as amended, debated and agreed to.

Clause 4 debated and agreed to.

Clause 5-

On the motion of Mr. Higgs, after debate, the following new paragraph was inserted to follow line 14:

"(aa) by inserting in sub-section (1.) after the word 'widow' the words 'or the widowed mother of an unmarried son';"

Mr. Brennan moved the following further amendment:-

Line 20, omit "Ten".

Debate ensued.

Question-That the word proposed to be omitted stand part of the clause-put.

13. WAR PENSIONS BILL (1916).—The Order of the Day having been read for the further consideration of this Bill in Committee of the whole House—Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

# (In the Committee.)

Clause 5 further considered-

On the motion of Mr. Higgs, after debate, the following further amendment was made:-

Page 3, line 20, omit "shillings per fortnight", and insert "Twenty shillings per fortnight for the first child, Fifteen shillings per fortnight for the second child, and Ten shillings per fortnight for the third and each subsequent child ".

On the motion of Mr. Higgs, the following further amendments were made:-

Lines 28-32, omit " in the following cases shall be as follows:-

- (a) to a child whose mother is dead and whose father is totally or partially incapacitated, Fifteen shillings per fortnight;
- (b) to a child".

Line 32, after "dead" insert "shall be".

Mr. Yates moved the following further amendment: --

Page 3, line 48, after "Second" insert "and Third".

Proposed amendment debated and negatived.

On the motion of Mr. Higgs, the following further amendment was made:-

Page 3, line 48, omit "unless otherwise prescribed".

Clause, as amended, agreed to.

Clauses 6 to 9 agreed to.

Clause 10 debated and agreed to.

Clause 11 agreed to.

Clause 12 debated-

Mr. Charlton moved, That the following words be omitted from the Second Schedule:-

"The maximum rate for six months, thereafter three-fourths of the maximum rate. The maximum rate for six months, thereafter three-fourths of the maximum rate.'

Proposed amendment debated, and, by leave, withdrawn.

On the motion of Mr. Higgs the following amendment was made:-

Omit the following words :-

"for at least six months, and thereafter subject to reduction to seven-eighths of the maximum rate if and so long as the member is capable of earning at least Six shillings a week."

Clause, as amended, agreed to.

Title agreed to.

Bill to be reported with amendments.

The House resumed; Mr. Chanter reported accordingly.

Mr. Higgs moved, by leave, That the Bill be now recommitted to a Committee of the whole House for the consideration of a further amendment in Clause 3.

Question—put and passed.

Mr. Speaker left the Chair, and the House again resolved itself into a Committee of the Whole.

### (In the Committee.)

Page 2, Clause 3-

On the motion of Mr. Higgs the following amendment was made :-

After line 25 insert the following new paragraph:-

"(aa) by inserting in the definition of 'member of the forces', after the words 'ship of war', the words 'or enlisted or appointed for service in connexion with naval or military preparations or operations; and".

Bill to be reported with a further amendment.

The House resumed; Mr. Chanter reported accordingly.

On the motion of Mr. Higgs, by leave, the House adopted the Reports.

Ordered—That the third reading be made an Order of the Day for to-morrow.

14. Public Service (Acting Commissioner) Bill.—.The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time-Debate resumed.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Clauses 1 and 2 agreed to.

Title agreed to.

Bill to be reported without amendment.

The House resumed; Mr. Charlton reported accordingly.

On the motion of Mr. Tudor, the House adopted the Report, and, by leave, the Bill was read a third

- 16. POSTPONEMENT OF ORDER OF THE DAY.—Ordered—That the consideration of Order of the Day Government Business, No. 2, be postponed until after Order of the Day No. 3.
- 17. War-time Profits Tax Assessment Bill.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time— Debate resumed.

Mr. Joseph Cook, addressing the House, and not having concluded his speech, the House ordered that he have leave to continue his speech when the debate is resumed.

Ordered-That the debate be now adjourned, and that the resumption of the debate be made an Order of the Day for to-morrow.

- 18. Postponement of Orders of the Day.—Ordered, That the intervening Orders of the Day be postponed until after Order of the Day, No. 18.
- 19. Customs House, Sydney: Alterations, &c.—Further Remission to Public Works Committee. -The Order of the Day having been read for the resumption of the debate on the following motion of Mr. O'Malley: -- That the Parliamentary Standing Committee on Public Works having reported to the House the result of their inquiries into the proposed alterations and additions to the Customs House, Sydney, and the Minister having obtained estimates of cost, £51,481 7s. 11d., tabled herewith, more closely calculated than those upon which the Committee reported, involving virtually double the Committee's estimate of cost, £29,000, the House resolves that their Report be remitted to the Committee for further consideration, and report as to the expediency of the work.

Question—put and passed.

- 20. Additional Day of Sitting .- Mr. Tudor moved, That the House, at its rising, adjourn until to morrow at half-past ten o'clock a.m. Question—put and passed.
- 21. ADJOURNMENT.—Mr. Tudor moved, That the House do now adjourn. Debate ensued.
