 - "but, in the opinion of this House, the Prime Minister (Mr. Hughes) and the Minister for the Navy (Mr. Cook) cannot represent Australian public opinion in London, for the following reasons, viz. :- (a) The speeches of the Prime Minister at and in relation to the Paris Conference; (b) The war policy of Ministers, which has been emphatically repudiated by two referendums of the Australian people; (c) The conduct of public affairs in Australia "-
