# THURSDAY, 6TH JUNE, 1918.

- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. PRINTING COMMITTEE-SECOND REPORT FROM .- Mr. McWilliams, for the Chairman, brought up the Second Report from the Printing Committee (sitting in conference with the Printing Committee of the Senate).

The Report was read by the Clerk, as follows:—

## SECOND REPORT.

The Printing Committee have the honour to report that they have met in conference with the Printing Committee of the Senate.

The Joint Committee, having considered the Petitions and Papers presented to Parliament since the last meeting of the Committee, recommend that the following be printed:-

Mr. McWilliams moved, by leave, That the Report be adopted. Question—put and passed.

3. Papers.—The following Papers were presented, pursuant to Statute-

Arbitration (Public Service) Act—Award (dated 13th May, 1918) of the Commonwealth Court of Conciliation and Arbitration, and other documents, in connexion with a plaint submitted by the General Division Officers' Union of the Trade and Customs Department of Australia.

4. Australian Soldiers' Repatriation Bill (1918).—The Order of the Day having been read for the further consideration of this Bill in Committee of the whole House—Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

### (In the Committee.)

Clauses 2 to 5 agreed to.

Clause 6

Mr. Groom moved, as an amendment, That paragraph (i) (lines 29-34) be omitted, and that the following paragraph be inserted in place thereof:—

"(i) who have been declared by the competent Naval or Military Medical Board at the headquarters abroad of the Australian Naval or Military Forces to be medically unfit for service, and who have been returned, or whom it is proposed to return, to Australia, or"

Amendment agreed to.

Mr. Groom moved, as an amendment, That paragraph (iii) (lines 44-7) be omitted, and that the following paragraph be inserted in place thereof:—

- "(iii) to the mothers of deceased or incapacitated Australian soldiers-
  - (a) who are widows and were, prior to the enlistment of those soldiers, dependent upon them; or
  - (b) whose husbands are so incapacitated as to be unable to contribute materially to their support."

Debate ensued.

Amendment agreed to.

Clause, as amended, agreed to.

Clause 7 agreed to.

Clause 8—

Mr. Considine moved, as an amendment, That the following words be inserted after the words "is amended":—"by inserting immediately after the word 'sailors' the words 'who have been previously selected by the returned soldiers and sailors of that State'".

Debate ensued.

Question—That the words proposed to be inserted be so inserted—put.

Clause agreed to.

Clause 9 debated.

Sir Robert Best moved, as an amendment, That the following words be added to paragraph (b):—

"and for the granting of assistance and benefits to any person who has enlisted or fought with the British Imperial the Australian Imperial or the British Dominion Forces in the present war or of any relative or dependant of such person."

Debate ensued.

Amendment, by leave, withdrawn.

Clause postponed.

Clauses 10 to 14 agreed to.

Clause 15 debated and agreed to.

Clause 16-

Mr. Groom moved, as an amendment, That all the words after the word "amended" (lines 39-42) be omitted, and that the following words be inserted in place thereof:—

"by omitting the words 'invite subscriptions or organize any scheme for raising money for the repatriation of Australian soldiers or for any purpose connected therewith' and inserting in their stead the words 'invite subscriptions or raise money by any means whatsoever for any patriotic fund or any fund in relation to the war'."

Debate ensued.

Question—That the amendment be agreed to—put.

- Mr. Groom moved, as an amendment, That paragraph (i) (lines 19-25) be omitted, and that the following paragraph be inserted in place thereof:—
  - "(i) who have been declared by the competent Naval or Military Medical Board at the head-quarters abroad of the Australian Naval or Military Forces to be medically unfit for service, and who have been returned, or whom it is proposed to return, to Australia, or".

Amendment agreed to.

- Mr. Groom moved, as an amendment, That paragraph (iii) (lines 36-9) be omitted, and that the following paragraph be inserted in place thereof:—
  - "(iii) to the mothers of deceased or incapacitated Australian soldiers-
    - (a) who are widows and were, prior to the enlistment of those soldiers, dependent upon them, or
    - (b) whose husbands are so incapacitated as to be unable to contribute materially to their support."

Amendment agreed to.

Clause, as amended, agreed to.

Postponed clause 9-

Mr. Groom moved, as an amendment, That the following words be inserted after the word "Act," (line 14):—

"or to any relative or person not specified in paragraphs (h), (c), or (d) of section twenty-two of this Act who was dependent upon any deceased or discharged sailor or soldier prior to his enlistment".

Debute ensued

Mr. Lamond moved, as an amendment upon the proposed amendment, That the words "relative or" be omitted.

Debate continued.

Amendment upon proposed amendment negatived.

Original amendment agreed to.

- Mr. Finlayson moved, as an amendment, That the following paragraph be added to the clause :--
  - "(c) by adding the following sub-section—'(5.) The member of the House of Representatives for the Electoral division in which Local Committees are appointed shall be cx officio a member of each Local Committee and Executive within the Division'."

Debate ensued.

Amendment negatived.

Clause, as amended, agreed to.

New clauses-

Mr. Jowett moved, That the following new clause be added to the Bill to stand as clause 18:-

"18. The provisions of this Act relating to the raising and distribution of funds by the Local Committee shall apply to members of the British Imperial and Dominion Imperial Forces who after discharge may settle within the Commonwealth of Australia."

Amendment ruled out of order.

Mr. Fenton moved, That the following new clause be added to the Bill to stand as clause 18:-

"18. The Minister shall appoint under the provisions of Australian Soldiers' Repatriation Acts qualified officers representing the Commonwealth Government to inspect and report upon properties which the State Governments propose to purchase for repatriation of Australian soldiers and sailors."

· Question--put and negatived.

Mr. Rodgers moved, That the following new clause be added to the Bill to stand as clause 18 .—

18. A Report of the operations under the Australian Soldiers' Repatriation Act shall be furnished annually.

Question put and passed.

Title agreed to.

Bill to be reported with amendments.

The House resumed; Mr. Chanter reported accordingly.

Mr. Groom moved, pursuant to contingent notice, That the Standing Orders be suspended, to enable the remaining stages to be passed without delay.

Question—put and passed.

On the motion of Mr. Groom, the House adopted the Report, and the Bill was read a third time.
