- 1. The House met, at eleven o'clock a.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. PAPER.—The following Paper was presented, by command of His Excellency the Governor-General— Royal Australian Naval College—Report for 1917.

Ordered to lie on the Table, and to be printed.

3. AUSTRALIAN SOLDIERS' REPATRIATION BILL (1918).—SENATE'S MESSAGE NO. 58.—The Order of the Day having been read for the consideration in Committee of the whole House of the Senate's Message No. 58—Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

The Committee proceeded to consider the Amendments, which are as follow :----

Schedule of the Amendments of the House of Representatives to which the Senate has agreed with Amendments.

No. 2.—Page 2, clause 6, lines 44-47, omit paragraph (iii), insert—

- "(iii) to the mothers of deceased or incapacitated Australian soldiers-
 - (a) who are widows and were, prior to the enlistment of those soldiers, dependent upon them, or
 - (b) whose husbands are so incapacitated as to be unable to contribute materially to their support,".

Amendment agreed to with the following amendment, viz. :-

At end of paragraph (iii) add the following new paragraph :---

"and (iv) the incapacitated fathers of dece-sed or incapacitated Australian soldiers who were, prior to the enlistment of those soldiers, dependent upon them."

No. 3.—Page 3, clause 9, line 14, after "Act" insert-

"or to any relative or person not specified in paragraphs (b), (c), or (d) of section twentytwo of this Act who was dependent upon any deceased or discharged sailor or soldier prior to his enlistment".

Amendment agreed to with the following amendment, viz. :---

Line 2, leave out "discharged sailor or", and insert "incapacitated Australian" in lieu thereof.

No. 6.—Page 5, clause 17, lines 36-39, omit paragraph (iii), insert—

"(iii) to the mothers of deceased or incapacitated Australian soldiers-

- (a) who are widows and were, prior to the enlistment of those soldiers, dependent upon them, or
- (b) whose husbands are so incapacitated as to be unable to contribute materially to their support."

Amendment agreed to with the following amendment, viz. :--

At end of paragraph (iii) add the following new paragraph :---

"and (iv) the incapacitated fathers of deceased or incapacitated Australian soldiers who were, prior to the enlistment of those soldiers, dependent upon them."

Amendment of the Senate to Amendment No. 2 agreed to.

On the motion of Mr. Groom, the amendment made by the Senate to Amendment No. 3 was, after debate, agreed to with the following amendment :---

Omit "incapacitated", insert "discharged".

Amendment of the Senate to Amendment No. 6 agreed to after debate. Resolutions to be reported.

The House resumed ; Mr. Chanter reported accordingly. On the motion of Mr. Groom, the House adopted the Report.

4. DEFENCE BILL (1918).—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time. Debate resumed.

Question—put and passed.—Bill read a second time.

Mr. Higgs, proposing to move, in accordance with notice given by Mr. Tudor—That it be an instruction to the Committee to insert a clause to the effect that sons of nineteen years shall not be enlisted for active service abroad without the consent of their parents first obtained—

Speaker's Ruling.—Mr. Speaker ruled that the motion was out of order on the ground that such a motion could not be moved by a Member other than the Member who had given Notice of the proposed Instruction.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Clause 1 debated and agreed to.

Clause 2 agreed to.

Clause 3 amended, on the motion of Mr. Wise, by the omission (page 2, line 1) of the word "the", second occurring.

Clause, as amended, agreed to.

Clause 4 amended, on the motion of Mr. Wise, by the omission of paragraph (a) and by the insertion of the following paragraph in place thereof:—

"(a) if voluntarily enlisted or appointed—upon the expiration of the period for which he engaged;".

Clause, as amended, agreed to.

Clauses 5 to 8 agreed to.

New clauses ----

Mr. Higgs moved, That the following new clause be added to the Bill to stand as clause 9 :---

Sons of nineteen years shall not be enlisted for active service abroad without the consent of their parents first obtained.

Proposed new clause ruled out of order as being outside the scope of the Bill.

Title agreed to.

Bill to be reported with amendments.

The House resumed; Mr. Chanter reported accordingly.

Mr. Wise moved, pursuant to contingent notice, That the Standing Orders be suspended to enable the remaining stages to be passed without delay.

On the motion of Mr. Wise, the House adopted the Report.

Consideration resumed of the following motion of Mr. Jensen-That it is expedient that an appropriation of revenue and money be made for the purposes of a Bill for an Act relating to the Payment of a Bounty on the Export of Evaporated Apples from the Commonwealth.

Mr. Sinclair moved, as an amendment, That the words "the export from Australia of" be omitted and that the words "or sold in Australia prior to the 31st of July, 1919" be inserted after the word "grown" (line 12).

Proposed amendment ruled out of order on the ground that the amendment went beyond the appropriation recommended for the Bill.

Mr. Higgs moved, as an amendment, That the following words be added to sub-clause (2.)-

"and before the bounty is paid the grower shall sign with his own signature a receipt therefor".

Debate ensued.

Amendment negatived.

Clause agreed to.

Clause 4 agreed to.

Clause 5 .---

Mr. Higgs moved, as an amendment, That the words "or factory in which they were evaporated or in which they have undergone any process" (lines 24-25), be omitted from the clause.

Debate ensued. Amendment negatived.

Clause agreed to.

Clauses 6 to 9 agreed to.

Preamble agreed to.

Title agreed to.

Bill to be reported without amendment.

The House resumed ; Mr. Chanter reported accordingly. On the motion of Mr. Jensen, the House adopted the Report, and the Bill was read a third time.

Mr. Groom having laid on the Table plans, &c., in connexion with the proposed work—Question—put and passed.
- PAPER.—The following Paper was presented, by command of His Excellency the Governor-General— The War—Supplementary Return showing Persons of Enemy Birth and Enemy Descent employed in the Department of Defence.
