- 3. ADJOURNMENT-MOTION FOR PURPOSE OF DISCUSSION.-Mr. Charlton rose in his place, and said that he proposed to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely, "Misleading statements made by a firm in Victoria for the purpose of inducing men to proceed to New South Wales for mining purposes, and in consequence deceiving returned soldiers who are left stranded in that State."

Mr. Speaker thereupon called upon those Members who approved of the proposed discussion to rise in their places, and more than the necessary number of Members having accordingly risen-

Mr. Charlton moved, That the House do now adjourn.

Debate ensued.
