- 2. MINISTERIAL STATEMENT—ANZAC TWEED INDUSTRY.—Mr. Poynton, by leave, made a Ministerial Statement with reference to the Anzac Tweed Industry.
- 3. PRINTING COMMITTEE-FOURTH REPORT FROM.-Mr. West, for the Chairman, brought up the Fourth Report from the Printing Committee (sitting in conference with the Printing Committee of the Senate).

NAURU ISLAND AGREEMENT BILL .- Mr. Hughes moved, pursuant to notice, That he have leave to bring in a Bill for an Act to approve the agreement made between His Majesty's Government in London, His Majesty's Government of the Commonwealth of Australia, and His Majesty's Government of the Dominion of New Zealand, in relation to the Island of Nauru. Question—put and passed.

Mr. Hughes brought up the Bill accordingly, and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Ordered-That the second reading be made an Order of the Day for to-morrow.

6. Peace Treaty between Allies and Germany.—The Order of the Day having been read for the resumption of the debate on the following motion of Mr. Hughes—That this House approves of the Treaty of Peace between the Allied and Associated Powers and Germany signed at Versailles on the 28th June, 1919—and on the Amendment moved thereto by Mr. J. H. Catts, viz.:—That the following words be added to the motion—"That owing to the limited amount of information placed before Parliament in relation to the Peace Treaty, its commitments and responsibilities, the whole matter be referred to a Committee of both Houses of the Parliament for inquiry and report "-

Debate resumed.

Mr. Burchell moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered—That the resumption of the debate be made an Order of the Day for to-morrow.

7. ADJOURNMENT.—Mr. Poynton moved, That the House do now adjourn.
