- 2. JOINT COMMITTEE OF PUBLIC ACCOUNTS.--Mr. Fenton, for the Chairman of the Joint Committee of Public Accounts, brought up the Minutes of Evidence of the Committee in connexion with the Report on :---

The Purchase of Saw-mills and Timber Areas by the War Service Homes Commissioner.

3. WAYS AND MEANS RESOLUTIONS [CUSTOMS AND EXCISE TARIFFS].--The Order of the Day having been read for the consideration of the Resolutions reported from the Committee of Ways and Means with respect to Duties of Customs and Excise--

4. CUSTOMS TARIFF BILL (1921),—Mr. Greene then brought up a Bill, intituled "A Bill for an Act relating to Dutics of Customs," and moved, That it be now read a first time. Question—put and passed.—Bill read a first time.

Mr. Greene moved-That the Bill be now read a second time.

Debate ensued.

Question—put and passed —Bill read a second time. Mr. Deputy Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Clauses 1 and 2 agreed to. Clause 3 debated and agreed to. Clauses 4 to 10 agreed to. Clause 11 debated and agreed to. Clauses 12 to 14 agreed to. Schedule agreed to. Title agreed to. Bill to be reported without amendment.

The House resumed ; Mr. Watkins reported accordingly. On the motion of Mr. Greene, the House adopted the Report, and the Bill was read a third time.

5. WAYS AND MEANS RESOLUTION [EXCISE TARIFF] -The Resolution of the Committee of Ways and

Means with respect to the Duties of Excise was then considered-Mr. Greene moved, pursuant to contingent notice, That the Standing Orders be suspended, to enable the remaining stages to be passed without delay.

Question-put and passed.

The Resolution reported from the Committee of Ways and Means was read and adopted by the House. Ordered--That Mr. Greene and Sir Joseph Cook do prepare and bring in a Bill to carry out the said Resolution.

6. EXCISE TARIFF BILL.—Mr Greene then brought up a Bill, intituled "A Bill for an Act relating to Duties of Excise," and moved, That it be now read a first time. Question—put and passed.—Bill read a first time.

Mr. Greene moved, That the Bill be now read a second time.

Question-put and passed.-Bill read a second time.

Mr. Deputy-Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Clauses 1 to 7 agreed to. Clause 8-

On the motion of Mr. Greene, the clause was amended by adding the following :---"Excise Tariff Validation Act 1917 (No. 7 of 1917).

Excise Tariff Validation Act 1919 (No. 18 of 1919).

Clause, as amended, agreed to.

Clause 9-

On the motion of Mr. Greene, the following amendment was made in the clause :---Line 1, omit "cease"; insert ", be deemed to have ceased".

Clause, as amended, agreed to.

Schedule agreed to. Title agreed to.

Bill to be reported with amendments.

The House resumed; Mr. Watkins reported accordingly.

On the motion of Mr. Greene, the House adopted the Report, and the Bill, after debate, was read a third time.

7. PAPERS.-The following Papers were presented, pursuant to Statute-

War Service Homes Act-Land acquired under, in New South Wales, at-Auburn, Bathurst, North Bondi, Orange.

8. ADJOURNMENT.-Sir Joseph Cook moved, That the House do now adjourn. Debate ensued.

Question-put and passed.
