Vote—"The Home and Territories Department £42,432" agreed to.

Vote—"The Department of Defence—Military £1,134,251.

Debate ensued.

Mr. Charlton moved, That the vote be reduced by £500,000.

Debate continued.

Sir Joseph Cook moved, That the Votes "The Department of Defence—Military", "The Department of the Navy", and "Departments of Navy and Defence—Air Services" be postponed until after the consideration of the other Votes for Additions, New Works, Buildings, &c.

Debate ensued.

Progress to be reported, and leave asked to sit again.

The House resumed; Mr. Chanter reported accordingly.

Resolved-That the House will, to-morrow, again resolve itself into the said Committee.
