3. MINISTERIAL STATEMENT RE IMPERIAL CONFERENCE, -- MOTION FOR PRINTING STATEMENT. -- Mr. Hughes, by leave, made a Ministerial Statement with reference to the Imperial Conference, which was recently held in Great Britain, and in conclusion, moved, That the Statement be printed. Mr. Charlton moved, That the debate be now adjourned.

Ordered-That the resumption of the debate be made an Order of the Day for the next day of sitting.

Vote—"The Department of Trade and Customs £4,831" debated and agreed to. Vote—"The Postmaster-General's Department £823,506" debated.

Progress to be reported, and leave asked to sit again.

The House resumed; Mr. Chanter reported accordingly.

Resolved—That the House will, at its next sitting, again resolve itself into the said Committee.

5. ALTERATION OF DAY OF NEXT MEETING. -Mr. Hughes moved, That the House, at its rising, adjourn until Wednesday next, at three o'clock p.m.

- 6. Ministerial Statement—"Diggers'" Loan—£10,000,000.—Sir Joseph Cook, by leave, made a Ministerial Statement with reference to the recent successful flotation of the "Diggers'" Loan of £10,000,000.
- 7. ADJOURNMENT.—Mr. Hughes moved, That the House do now adjourn. Debate ensued.

Question—put and passed.
