WEDNESDAY, 4TH JULY, 1923.

- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. Joint Committee of Public Accounts—Report.—Mr. Bayley, Chairman of the Joint Committee of Public Accounts, brought up the following Report from the Committee:—

- 4. Postponement of Orders of the Day.—Ordered—That Orders of the Day Nos. 1 and 2 be postponed until after Order of the Day No. 3.
- 5. Commonwealth Shipping Bill.—The Order of the Day having been read for the consideration in Committee of the whole House of His Excellency the Governor-General's Message No. 8—

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Resolved, on the motion of Mr. Bruce (Prime Minister)—That it is expedient that an appropriation of revenue be made for the purposes of a Bill for an Act to provide for the Establishment of the Commonwealth Shipping Line and for other purposes.

Resolution to be reported.

The House resumed; Mr. Bamford reported accordingly.

Mr. Bruce moved, pursuant to contingent notice, That the Standing Orders be suspended, to enable the remaining stages to be passed without delay.

Question—put and passed.

The Resolution reported from the Committee was read, and, on the motion of Mr. Bruce, was adopted by the House.

Ordered—That Mr. Bruce and Mr. Groom do prepare and bring in a Bill to carry out the foregoing Resolution.

Mr. Bruce then brought up the Bill accordingly, and moved, That it be now read a first time. Question—put and passed.—Bill read a first time.

Ordered-That the second reading be made an Order of the Day for a later hour this day.

6. NATIONAL DEBT SINKING FUND BILL.—The Order of the Day having been read for the further consideration of this Bill in Committee of the whole House—Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Thereupon Mr. Speaker, with Members of the House, went to attend His Excellency the Governor-General, at Government House, and having returned, Mr. Speaker reported that he had presented the Address in Reply to His Excellency's Speech on the Opening of Parliament, agreed to by the House on the 22nd ultimo, and that His Excellency had been pleased to make the following

Mr. Speaker and Gentlemen-

I receive with much pleasure the Address which has been adopted by the House of Representatives in reply to the Speech which I delivered on the occasion of the Opening of the Second Session of the Ninth Parliament of the Commonwealth; and desire to thank you for your expression of loyalty to His Majesty the King.

- 11. Message from the Governor-General.—Meat Export Bounties Bill (1923).—The following Message from His Excellency the Governor-General was presented, and the same was read by Mr. Speaker:—

FORSTER,

Message No. 9.

Governor-General.

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of an amendment extending the period for the slaughter of beasts in respect of the export of which Bounty is payable under a Bill for an Act to provide for the payment of Bounties on the Export of Reef and Cattle from the Commonwealth.

Ordered—That the foregoing Message be considered in Committee of the whole House, forthwith. Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Resolved, on the motion of Mr. Austin Chapman (Minister for Trade and Customs)—That it is expedient that an appropriation of revenue be made for the purposes of an amendment extending the period for the slaughter of beasts in respect of the export of which Bounty is payable under a Bill for an Act to provide for the payment of Bounties on the Export of Beef and Cattle from the Commonwealth.
