THURSDAY, 5TH JULY, 1923

1. The House met, at half-past two o'clock p.m., pursuant to adjournment.--Mr. Speaker took the Chair, and read Prayers.

2. PAPER.-The following Paper was presented, pursuant to Statute-

Tariff Board-Annual Report, to June, 1923-together with accompanying Schedule.

3. ADJOURNMENT-MOTION FOR PURPOSE OF DISCUSSION .-- Mr. Bamford rose in his place, and said that he proposed to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely, "The unsatisfactory condition in which the sugar industry is placed owing to the proposed arrangement under which the price of raw sugar will be reduced to £27 per ton, and the placing of an embargo of only two years upon the importation of foreign sugar '

Mr. Speaker thereupon called upon those Members who approved of the proposed discussion to rise in their places, and more than the necessary number of Members having risen accordingly-Mr. Bamford moved, That the House do now adjourn.

Mr. Bamford not having concluded his speech at the termination of the time allowed by Standing Order No. 39, the honorable Member was given leave to continue his speech.

Mr. Bruce (Prime Minister) addressing the House, and not having concluded his speech at the termination of the time allowed by Standing Order No. 39, the Right Honorable Member was given leave to continue his speech.

Debate continued.

- It being two hours after the time fixed for the meeting of the House, the debate was interrupted in accordance with Standing Order No. 119, and the Order of the Day, General Business, was called on.
- 4. POSTPONEMENT OF ORDER OF THE DAY .- Ordered, That Order of the Day, No. 1, General Business, be postponed until Thursday next.
- 5. POSTFONEMENT OF NOTICE OF MOTION .- Ordered, That the consideration of Notice of Motion, No. 1, General Business, be postponed until Thursday next.
- 6. EX-GUNNER YATES-SELECT COMMITTEE.-Mr. Charlton moved, pursuant to notice, That a Select Committee be appointed for the purpose of inquiring into the statements made by the late Minister for Defence, Senator Pearce, and the ex-Prime Minister, the Right Honorable W. M. Hughes, reflecting on the character of ex-Gunner Yates, with power to recommend compensation if deemed necessary.

Debate ensued.

Mr. Groom (Attorney-General) moved, That the debate be now adjourned.

Question-That the debate be now adjourned-put and passed.

Ordered-That the resumption of the debate be made an Order of the Day for Thursday next.

7. "HANSARD"-AUTHORIZATION OF PUBLICATION.-Sir Elliot Johnson moved, pursuant to notice, That, in the opinion of this House, with a view to removing the uncertainty which exists at the present time as to the authority for the publication of the Parliamentary Hansard, section 3 of the Parliamentary Papers Act should be amended to include Hansard among the documents authorized by Parliament to be printed and published.

Debate ensued.

Mr. W. Maloney moved, That the debate be now adjourned.

Question-That the debate be now adjourned-put and passed.

Ordered-That the resumption of the debate be made an Order of the Day for Thursday, 19th instant .

8. SHIPPING SERVICE-MELBOURNE AND HOBART-SELECT COMMITTEE.-Mr. O'Keefe moved, pursuant to notice, That a Select Committee be appointed to inquire into the necessity for the Commonwealth Government making provision for an adequate direct shipping service between Melbourne and Hobart.

Mr. O'Keefe not having concluded his speech, the House ordered that the honorable Member have leave to continue his speech when the debate is resumed.

- Ordered-That the debate be now adjourned, and that the resumption of the debate be made an Order of the Day for Thursday next.
- 9. WITHDRAWAL OF NOTICE OF MOTION .- Mr. Coleman withdrew the Notice of Motion standing in his name with reference to the disallowance of Statutory Rule No. 69 of 1923 (Repatriation Regulations).

On the motion of Mr. Austin Chapman (the Standing Orders having been previously suspended-see p. 50 ante), the House adopted the Reports and the Bill was read a third time.
