THURSDAY, 12TH JULY, 1923.

- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. Parliamentary Standing Committee on Public Works, Beports.—Mr. Gregory, Chairman of the Parliamentary Standing Committee on Public Works, brought up the following Reports from the Committee:—

Report, together with Minutes of Evidence and Plans, relating to the Construction of Provisional Administrative Offices at Canberra.

Report, together with Minutes of Evidence, Appendices and Plans, relating to the proposed Erection of Provisional Parliament House, Canberra.

Report, together with Minutes of Evidence, relating to the Erection of Officers' Hostel, Canberra.

Mr. Gregory moved, That the Reports be printed.

Mr. Blakeley moved, as an amendment, That the following words be added to the motion:—"and that the Minority Report (as regards the Provisional Parliament House) signed by Arthur Blakeley, member of the Public Works Committee, be also printed."

Debate ensued.

Mr. Bruce (Prime Minister) moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered-That the resumption of the debate be made an Order of the Day for Thursday next.

- 3. Postponement of Notice of Motion—Ordered—That the consideration of Notice of Motion No. 1, General Business, be postponed until Thursday next.
- ' 4. DESTITUTE ALLOWANCE.—Mr. W. Maloney moved, pursuant to notice—
 - (1) That this House is of opinion that the Invalid and Old-age Pensions Act should be amended in order to provide for a destitute allowance to be made to all inhabitants who are destitute, so that any person making a statutory declaration (to a postmaster, Customs officer, or other appointed Commonwealth official, a schoolmaster, a union secretary, a magistrate, or other appointed individual) that he or she is insufficiently fed, clothed, or sheltered, shall be paid as soon as possible the sum of 15s. per week, and for each child 10s. per week, until relieved.
 - (2) That the passing of the foregoing resolution be an instruction to the Government of the Commonwealth to bring in the necessary amending Act.

Debate ensued.

Mr. Groom (Attorney-General) moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered-That the resumption of the debate be made an Order of the Day for Thursday, 26th instant.

- 5. Postponement of Notice of Motion.—Ordered—That the consideration of Notice of Motion No. 3, General Business, be postponed until Thursday next.
- 6. Navigation Act—Effect on Trade.—Select Committee.—Mr. Prowse moved, pursuant to notice, amended, That, in the opinion of this House, a Select Committee should be appointed to inquire into and report upon the effect of the operation of the Navigation Act upon Australian trade, industry, and development in the various States and Mandated Territories of the Commonwealth.

Mr. Prowse not having concluded his speech, the House ordered that the honorable Member have leave to continue his speech when the debate is resumed.

Ordered—That the debate be now adjourned, and that the resumption of the debate be made an Order of the Day for Thursday next.
