WEDNESDAY, 25TH JUNE, 1924.

- 1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Right Honorable W. A. Watt) took the Chair, and read Prayers.
- 2. Death of Senator Barker.—Mr. Bruce (Prime Minister) having announced, with deep regret, the death, on the 21st instant, of Senator Barker, moved, by leave, That this House expresses its sincere regret at the death of Senator Stephen Barker, and places upon record its appreciation of his meritorious public service, and extends its profound sympathy to his family in their sad hereavement.

And Mr. Charlton (Leader of the Opposition) having seconded the motion, and Mr. W. Maloney having addressed the House in support thereof, and all Members present having risen in silence—Question—passed.

Resolved—That Mr. Speaker be requested to transmit to the relatives the foregoing Resolution, and a copy of the addresses delivered thereon.

- 3. Suspension of Sitting as Mark of Respect.—As a mark of respect to the memory of the late honorable Senator, the sitting was thereupon suspended until eight o'clock p.m.
- 4. RESUMPTION OF SITTING.—At eight o'clock p.m. Mr. Speaker resumed the Chair.

Mr. Earle Page (Treasurer) moved—That there be granted to His Majesty for or towards defraying the services of the year 1924-25 a sum not exceeding £4,076,175.

Debate ensued-

And the Committee continuing to sit till after midnight-

THURSDAY, 26TH JUNE, 1924.

Debate continued.

Question—put and passed.

Resolution to be reported, and leave asked to sit again.

The House resumed; Mr. Watkins reported accordingly.

Resolved-That the House will, at the next sitting, again resolve itself into the said Committee.

11. Suspension of Standing Orders.—Mr. Earle Page (Treasurer) moved, pursuant to contingent notice, That the Standing Orders be suspended to enable the remaining stages to be passed without delay.

Question—put and passed.

- 12. Supply Resolution.—The Resolution reported from the Committee of Supply was read, and, on the motion of Mr. Earle Page (Treasurer), was adopted by the House.
- 13. Ways and Means Resolution.—The House, according to order, resolved itself into the Committee of Ways and Means.

(In the Committee.)

Supply Bill (No. 1) 1924-25.

Resolved, on the motion of Mr. Earle Page (Treasurer)—That, towards making good the Supply granted to His Majesty for the services of the year 1924-25, there be granted out of the Consolidated Revenue Fund a sum not exceeding £4,076,175.

Resolution to be reported, and leave asked to sit again.

The House resumed; Mr. Watkins reported accordingly.

Resolved-That the House will, at the next sitting, again resolve itself into the said Committee.

25th and 26th June, 1924.

The Resolution reported from the Committee was read, and, on the motion of Mr. Earle Page, was adopted by the House.

Ordered-That Mr. Earle Page and Mr. Bruce do prepare and bring in a Bill to carry out the foregoing Resolution.

14. Supply Bill (No. 1) 1924-25.—Mr. Earle Page (Treasurer) then brought up a Bill intituled "A Bill for an Act to grant and apply a sum out of the Consolidated Revenue Fund for the service of the year ending the thirtieth day of June One thousand nine hundred and twenty-five," and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Mr. Earle Page moved, That the Bill be now read a second time.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Bill, by leave, taken as a whole, and agreed to. Bill to be reported without amendment.

The House resumed; Mr. Watkins reported accordingly. On the motion of Mr. Earle Page, the House adopted the Report, and the Bill was read a third time.

15. Adjournment -Mr. Bruce (Prime Minister) moved, That the House do now adjourn. Question—put and passed.

And then the House, at twelve minutes to one o'clock in the morning, adjourned until this day at half-past two o'clock p.m.
