THURSDAY, 31st JULY, 1924.

- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Right Honorable W. A. Watt) took the Chair, and read Prayers.
- 2. Adjournment-Motion for Purpose of Discussion Mr. Corser rose in his place, and said that he proposed to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely, "The precarious condition of the Dairying Industry of the Commonwealth and the necessity for prompt action by the Government for stabilizing the industry".
 - Mr. Speaker thereupon called upon those Members who approved of the proposed discussion to rise in their places, and more than the necessary number of Members having risen accordingly—
 - Mr. Corser moved, That the House do now adjourn.

Debate ensued.

- It being two hours after the time fixed for the meeting of the House, the debate was interrupted in accordance with Standing Order No. 119, and the Business of the Day was called on.
- 3. - 4. QUARANTINE BILL (1924).—Mr. Pratten (Minister for Trade and Customs), pursuant to leave given on the 1st April last, brought up a Bill intituled "A Bill for an Act to amend the Quarantine Act 1908-1920," and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Ordered to lie on the Table, and to be printed.

- 9. WAR PENSIONS APPROPRIATION BILL (1924).—The Order of the Day having been read for the consideration in Committee of the whole House of His Excellency the Governor-General's Message

Ordered—That Mr. Earle Page and Mr. Bruce do prepare and bring in a Bill to carry out the foregoing

Mr. Earle Page then brought up the Bill accordingly, and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Mr. Earle Page moved, That the Bill be now read a second time.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Bill, by leave, taken as a whole, and agreed to.

Bill to be reported without amendment.

The House resumed; Mr. Bamford reported accordingly.
