### WEDNESDAY, 6TH AUGUST, 1924.

- 1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Right Honorable W. A. Watt) took the Chair, and read Prayers.
- 2. Message from the Governor-General.—Assent to Bill.—The following Message from His Excellency the Governor-General was received, and the same was read by Mr. Speaker:—

FORSTER,

Governor-General.

Message No. 52.

A Bill intituled "Commonwealth Electoral Act 1924" as finally passed by the Senate and the House of Representatives of the Commonwealth, having been presented to the Governor-General for the Royal Assent, His Excellency has, in the name and on behalf of His Majesty, assented to the said Act.

- 3. MINISTRY RESIGNATION OF MINISTER FOR WORKS AND BAHWAYS.—Mr. Bruce (Prime Minister) announced to the House that Mr. Stewart had resigned his office as Minister for Works and Railways.
- 4. Paper.—The following Paper was presented, pursuant to Statute—

Canned Fruit Bounty Act—Statement of persons, &c., to whom Bounty has been paid to 31st July, 1921.

5. Printing Committee—Second Report from .—Mr. Corser, Chairman, brought up the Second Report from the Printing Committee (sitting in conference with the Printing Committee of the Senate).

#### REPORT.

The Printing Committee have the honour to report that they have met in Conference with the Printing Committee of the Senate.

6. Message from the Governor-General.—Loan Bill (1924).—The following Message from His Excellency the Governor-General was presented, and the same was read by Mr. Speaker:-FORSTER,

In accordance with the requirements of section 56 of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue and moneys be made for the purposes of a Bill for an Act to authorize the Raising and Expending of certain Sums of Money. Sydney, 2nd August, 1924.

Ordered-That the foregoing Message be taken into consideration, in Committee of the whole House, at a later hour this day.

7. Message from the Governor-General.—States Loan Bill (1924).—The following Message from His Excellency the Governor-General was presented, and the same was read by Mr. Speaker:-

FORSTER.

Governor-General. .

In accordance with the requirements of section 56 of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue and moneys be made for the purposes of a Bill for an Act to authorize the raising of Moneys to be loaned to the States, and for other purposes.

Sydney, 5th August, 1924.

Ordered—That the foregoing Message be taken into consideration, in Committee of the whole House, at a later hour this day.

8. Supply Resolution-Estimates-Additions, New Works, Buildings, etc., 1924-25.—The Order of the Day having been read for the consideration of the Resolution reported from the Committee of Supply, the said Resolution was read and is as follows:

That there be granted to His Majesty to the service of the year 1924-25, for the purposes of Additions, New Works, Buildings, &c., a sum not exceeding £403,789.

Mr. Earle Page (Treasurer) moved, That the Resolution be adopted. Question—put and passed.

9. Ways and Means Resolution-Estimates-Additions, New Works, Buildings, etc., 1924-25. -The House, according to Order, resolved itself into the Committee of Ways and Means.

(In the Committee.)

Additions, New Works, Buildings, etc., 1924-25.

Resolved, on the motion of Mr. Earle Page (Treasurer)—That, towards making good the Supply granted to His Majesty for Additions, New Works, Buildings, &c., for the year 1924-25, there be granted out of the Consolidated Revenue Fund a sum not exceeding £403,789.

Resolution to be reported, and leave asked to sit again.

The House resumed; Mr. Bamford reported accordingly.

Resolved—That the House will, at a later hour this day, again resolve itself into the said Committee. Mr. Earle Page moved, pursuant to contingent notice, That the Standing Orders be suspended to enable

the remaining stages to be passed without delay. Question—put and passed.

The Resolution reported from the Committee was read and, on the motion of Mr. Earle Page, was adopted by the House.

Ordered-That Mr. Earle Page and Mr. Bruce do prepare and bring in a Bill to carry out the foregoing Resolution.

10. APPROPRIATION (WORKS AND BUILDINGS) BILL 1924-25.-Mr. Earle Page (Treasurer) then brought up a Bill intituled "A Bill for an Act to grant and apply a sum out of the Consolidated Revenue Fund for the service of the year ending the thirtieth day of June One thousand nine hundred and twenty-five for the purposes of Additions, New Works, Buildings, &c., and to appropriate such sum," and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Mr. Earle Page moved, That the Bill be now read a second time.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Bill, by leave, taken as a whole and, after debate, agreed to. Bill to be reported without amendment.

The House resumed; Mr. Bamford reported accordingly.

On the motion of Mr. Earle Page the House adopted the Report, and the Bill was read a third time.

Progress to be reported, and leave asked to sit again.

Resolved—That the House will, at the next sitting, again resolve itself into the said Committee.

12. STATES LOAN BILL (1924).—The Order of the Day having been read for the consideration in Committee of the whole House of His Excellency the Governor-General's Message No. 54-

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Bill, by leave, taken as a whole, and agreed to.

Bill to be reported without amendment.

The House resumed; Mr. Robert Cook reported accordingly.

On the motion of Mr. Earle Page the House adopted the Report, and the Bill was read a third time.
