### FRIDAY, 12TH JUNE, 1925.

- 1. The House met, at eleven o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Right Honorable W. A. Watt) took the Chair, and read Prayers.
- 2. Want of Confidence in the Government.—Mr. Charlton (Leader of the Opposition) moved, by leave, That the Government is deserving of the severest censure for its flagrant breach of faith in failing to honour the definite promise of the Prime Minister to consult the House before determining where the second cruiser should be built, and for its anti-Australian action in sending millions of pounds out of the country for the construction of both cruisers abroad.

Debate ensued

- Mr. Mahony addressing the House, and not having concluded his speech, the House ordered that the honorable Member have leave to continue his speech when the debate is resumed.
- Ordered—That the debate be now adjourned, and that the resumption of the debate be made an Order of the Day for a later hour this day.
- 3. Postponement of all other Business until after Disposal of Want of Confidence Motion.—Sir Littleton Groom (Attorney-General) moved, That all other Business be postponed until after the Motion of Want of Confidence, now before the House, is disposed of.

Question—put and passed.

4.
