# FRIDAY, 26TH JUNE, 1925.

 The House met, at eleven o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Right Honorable W. A. Watt) took the Chair, and read Prayers.

2. PAPER.—The following Paper was presented, pursuant to Statute— Defence Act—Regulations Amended—Statutory Rules 1925, No. 98.

3. ORDER OF BUSINESS.—Mr. Bruce (Prime Minister) moved, pursuant to notice, That, unless otherwise ordered, Government Business shall take precedence on all sitting days except Thursdays, when General Business shall take precedence until half-past six o'clock p.m.

Question—put and passed.

4. ORDER OF GENERAL BUSINESS.—Mr. Bruce (Prime Minister) moved, pursuant to notice, That on Thursday in each week, unless otherwise ordered, General Business shall be called on in the following order, viz.:—

> On one Thursday— Notices of Motion. Orders of the Day. On the alternate Thursday— Orders of the Day. Notices of Motion.

- 6. INCOME TAX ASSESSMENT BILL (1925).—Mr. Earle Page (Treasurer) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to amend the *Income Tax Assessment Act* 1922-1924.
  - Question—put and passed.
- LAND TAX ASSESSMENT BILL (1925).—Mr. Earle Page (Treasurer) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to amend the Land Tax Assessment Act 1910-1924. Question—put and passed.
- DISTILLATION BILL (1925).—Mr. Pratten (Minister for Trade and Customs) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to amend section 40 of the *Distillation* Act 1901-1923.
  Question—put and passed.
- CUSTOMS BILL (1925).—Mr. Pratten (Minister for Trade and Customs) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to amend the *Customs Act* 1901-1923. Question—put and passed.

Question—put and passed.

Ordered—That Mr. Bruce and Mr. Earle Page do prepare and bring in a Bill to carry out the foregoing Resolution.

Mr. Bruce then brought up the Bill accordingly, and moved, That it be now read a first time.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.
