Australian Research Council Bill 2000–A message was reported (on 7/12/2000) that the House of Representatives had disagreed to amendments made by the Senate. The Senate did not insist on 4 amendments (and made 3 substitute amendments) and insisted on 7 of the amendments disagreed to by the House. [The House of Representatives will now consider the substitute amendments and the amendments insisted on by the Senate]

Australian Research Council (Consequential and Transitional Provisions) Bill 2000–A message was reported (on 7/12/2000) that the House of Representatives disagreed to amendments made by the Senate. The Senate insisted on the amendments disagreed to by the House. [The House of Representatives will now reconsider the amendments insisted on by the Senate]
