[The House of Representatives will now reconsider the amendments insisted on by the Senate and consider the amendments made by the Senate to the House amendments and the consequential amendment]

Dairy Produce Legislation Amendment (Supplementary Assistance) Bill 2001–The message reported that the House of Representatives had not made the amendment requested by the Senate, but had made amendments in place of the requested amendment. The Senate did not press the request not made by the House and agreed to the amendments made by the House.

Environment Protection and Biodiversity Conservation Amendment (Wildlife Protection) Bill 2001–The message reported that the House of Representatives had agreed to the bill <u>with amendments</u>. The Senate agreed to the amendments made by the House. [The bill will now be assented to] Taxation Laws Amendment (Superannuation Contributions) Bill 2000–The message reported that the House of Representatives disagreed to <u>the amendment made</u> by the Senate. The Senate did not insist on the amendment disagreed to by the House [The bill will now be assented to]
