The Senate met from 12.30pm until 10.29pm

Motion to disallow regulations defeated

The Senate debated a motion to disallow the Migration Amendment Regulations 2003 (No. 1) as contained in Statutory Rules 2003 No. 57 and made under the *Migration Act 1958*. The Senate agreed *not* to disallow the regulations.
