Senator Brown gave a notice of motion to require the Minister for the Environment and Heritage to table any assessment made since 1996 in preparation for, or consideration of, a world heritage nomination for the Sydney Opera House (no later than 3pm on 27 October 2003)

Senator Nettle gave a notice of motion to require the Minister representing the Minister for Trade to table documents detailing the results of the independent environmental and social audit of the Sepon Mine project in Laos, conducted by Graham A Brown and Associates and provided to the Export Finance Insurance Corporation (no later than 30 October 2003)

Statements by Ministers and documents tabled

The Minister for Fisheries, Forestry and Conservation made a statement and <u>tabled</u> <u>documents</u> relating to the voyage of the MV *Cormo Express*. The Minister <u>indicated</u> that another Master's report may be provided if ministerial approval is given.

The Special Minister of State made a statement and tabled <u>certain documents</u> relating to the proposed Australia-United States free trade agreement and the regulation of labelling of genetically-modified foods in Australia and/or the United States. The Minister <u>indicated</u> that the government is claiming public interest immunity for other documents required by the order.
