□ Broadcasting Services Amendment (Media Ownership) Bill 2002—second reading debate continued

□ Workplace Relations Amendment (Prohibition of Compulsory Union Fees) Bill 2002 [No. 2]–2 Democrat amendments agreed to and 4 items omitted [The House of Representatives will now consider the amendments made by the Senate]

The following bill was defeated at the third reading by a majority vote

□ Workplace Relations Amendment (Secret Ballots for Protected Action) Bill 2002 [No. 2] [This bill meets the requirements for a simultaneous dissolution of both houses under <u>s.57</u> of the Constitution]

□ Workplace Relations Amendment (Fair Dismissal) Bill 2002 [No. 2]—
The message reported that the House of Representatives had insisted on disagreeing to amendments made and insisted on by the Senate. The Senate resolved to further insist on the amendments made by the Senate to which the House had insisted on disagreeing [This bill meets the requirements for a simultaneous dissolution of both houses under s.57 of the Constitution]
