The Senate met from 12.30pm until 10.28pm

The following messages from the House of Representatives were considered

- □ Superannuation Government (Co-contribution for Low Income Earners) Bill 2003–The <u>message</u> reported that the House of Representatives agreed to amendments nos 1 to 4, 8 to 11, and 13 to 15 made by the Senate, and disagreed to amendments nos 5 to 7 and 12. The Senate <u>resolved</u> not to insist on the amendments disagreed to by the House. [The bill will now be assented to]
- □ Superannuation (Government Co-contribution for Low Income Earners) (Consequential Amendments) Bill 2003–The <u>message</u> reported that the House of Representatives agreed to amendments nos 7 and 12 made by the Senate, and disagreed to <u>amendments</u> nos 1 to 6 and 8 to 11. The Senate resolved not to insist on the amendments disagreed to by the House. [The bill will now be assented to]
- □ Superannuation (Surcharge Rate Reduction) Amendment Bill 2003—
 The <u>message</u> reported that the House of Representatives agreed to amendments nos 1 to 26 and 28 to 32, and disagreed to <u>amendment</u> no. 27 made by the Senate. The Senate <u>resolved</u> not to insist on the amendment disagreed to by the House. [The bill will now be assented to]

Senator Carr gave a notice of motion to require the Minister representing the Minister for Education, Science and Training to table the regional impact statement prepared by the Department of Education, Science and Training, in support, explanation and justification of the higher education policy package, referred to at the hearing of the Employment, Workplace Relations and Education References Committee on 17 October 2003 (no later than 29 October 2003)

Senator Harradine gave a <u>notice of motion</u> to require the Leader of the Government to table two certain expert reports relating to the use of human embryos for research (no later than immediately after motions to take note of answers on 29 October 2003)

Statement by Minister

The Minister for Local Government, Territories and Roads made a statement about the order for production of documents (<u>agreed</u> to 16 October 2003) requiring the Minister representing the Minister for Environment and Heritage to table any assessment made since 1996 in preparation for, or consideration of, a world heritage nomination for the Sydney Opera House (no later than 3 pm on 27 October 2003). <u>The Minister indicated</u> that the government expected to comply with the order by 30 October 2003.
