

# Senate Daily Summary

# **Tuesday 16 November 2004**

The Senate met from 10.30am until 6.01pm. The Senate agreed to meet on Wednesday 17 November 2004.

# Opening of 41<sup>st</sup> Parliament

The Deputy of the Governor-General opened the first session of the 41<sup>st</sup> Parliament in the Senate chamber. Following a suspension of sitting until 3pm, the Governor-General <u>addressed</u> the members of both houses assembled in the Senate chamber, outlining the government's proposed legislation for the session. The Governor-General's speech will be debated and this debate will provide the Senate's formal response (the Address-in-reply) to the opening speech.

## New senators sworn in

Senators for the Australian Capital Territory and Northern Territory, Senator Crossin (Australian Labor Party), Senator Humphries (Liberal Party), Senator Lundy (Australian Labor Party) and Senator Scullion (Country Liberal Party), were sworn in.

The Leader of the Government in the Senate advised the Senate of the Fourth Howard Ministry and ministerial arrangements in the Senate
