#### New committee system

Changes to the committee system will take effect from 11 September 2006. The changes include:

- establishing eight standing committees (combining the functions of the 16 legislation and references committees) with eight members each instead of six;
- a government senator to chair each standing committee, with a non-government senator as deputy chair;
- □ more flexible arrangements to appoint substitute members of committees.
- It is expected that members will be appointed to the new committees this week.
