The Minister for Finance and Administration tabled the <u>Budget statement</u> for the year 2006-07 and associated budget papers and ministerial statements. The Opposition, minor parties and independent senators will make their responses to the Budget statement on Thursday 11 May 2006.

The Senate agreed to <u>a motion</u> by the Minister for Finance and Administration to refer documents to legislation committees to enable the committees to examine the proposed budget. This initiates the estimates hearings process. Portfolio budget statements and portfolio supplementary additional estimates statements for <u>parliamentary</u> and <u>executive</u> <u>departments</u> were also tabled.
