# Thursday, 12 October 2006

The Senate met from 9.30am until 7.45pm

### **Bills considered**

The Senate agreed to a <u>motion</u> moved by the Minister for Justice and Customs limiting debate on the Broadcasting Services Amendment (Media Ownership) Bill 2006 and 3 related bills.

- Communications Legislation Amendment (Enforcement Powers) Bill 2006–7 government amendments agreed to [The House of Representatives will now consider the amendments made by the Senate]
- □ Television Licence Fees Amendment Bill 2006 [This bill will now be assented to]

- Community Affairs Committee–Senator Ferris to replace Senator Adams for the committee's inquiry into legislative responses to the Lockhart review on 24 October 2006
- □ Economics Committee–Senator Parry to replace Senator Bernardi for the committee's inquiry into petrol pricing in Australia on 13 October 2006
- □ Legal and Constitutional Affairs Committee–Senator Webber appointed as a participating member
